Contestant information forms (see back page of packet) must be submitted by Friday, March 27, 2015. Submit forms by returning them to the school office.

Auditions for all contestants will be Monday April 13th from 1:30 – 3:00 in the music room.

Dress Rehearsal (all finalists must attend)-Monday May 4th (during school hours.)

Rules and information *Entering and classification*

1. Any student currently attending CPA is eligible to enter.
2. Individuals or groups may enter in their division:
 - Kindergarten-2nd grade
 - 3rd grade-5th grade
 - 6th grade-8th grade

Note: Siblings who wish to perform in a group but whose ages span both divisions may enter either applicable division

3. Students must complete and submit the attached contestant information sheet to become an individual or group contestant. **All group contestant forms should be submitted together.**
4. Finalists will be posted on the music room door by April 17th.
5. All finalists **must** attend the dress rehearsal; acts that are not performance ready will be cut at this time.

Additional Rules/Guidelines

1. Acts are limited to five (5) minutes in length including set up, performance, and exit. For everyone's sake, this time limit will be strictly observed.
2. Acts may include, but are not limited to: dancing, singing, playing musical instruments, acting, reciting, miming, comedy, magic, or performing physical feats. Be creative!
3. Contestants chosen as finalists must use the same act, costume, and set in the show that they used in the audition. However, if more than one student auditions with the same piece of music, and is selected as a finalist, the act receiving the highest audition score will perform that piece and the other student will be asked to find a new performance piece.
4. Auditions and rehearsals are closed to parents, guardians, relatives, friends, sponsors, etc. No exceptions! Students need to be lined up in the hallway outside of the music room in audition order. Students must stay seated, and must stay quiet during this wait time. Audition times will be posted on the music room door the week prior to auditions. Parents, please make sure your child is there for their audition time, and then also arrange to pick them up right after their audition time.
5. Please label any recorded musical accompaniment with your name or group's name, the title of the act/song, and track number. Accompaniments must be on a CD. Please provide a CD that is not scratched. Scratches on CDs can result in a scary performance when the music suddenly stops. Yikes!

6. Parents are encouraged to assist performers off-stage in any way that may help them at auditions. This may be especially necessary for performers in the K-2 division.
7. For acts that involve singing, please assist your child in selecting a song that is age appropriate. **Please provide a karaoke CD accompaniment. That means NO lead vocals.**
8. Contestants may participate in one act only.
9. Acts must be performed in the talent show EXACTLY as they were performed at the dress rehearsal. This includes costumes, instruments, props, recordings, and accompanists. Dress the same at dress rehearsal (if chosen) for the talent show.
10. Music should be clearly marked with the proper starting point identified, the name of the actor/performer, and the name of the song.
