- a. Discipline Report: Included with Board packet. Jason Chesser reported behaviors causing suspensions were down in November. Excessive tardies are from a handful of families. Students are given a reflection sheet to complete, then a parent is required to sign.
- b. Assessment Update: Erin Keyes stated testing for DIBELS will be wrapping up. Many students are making progress. Scores are comparable with the District and other CSI schools. Erin Keyes shared a briefing report she received from NWEA, which shows recovering student achievement lost during the pandemic could take up to five years.
